**Issue?** What is the name of the legal principle you see violated?

**Rule?** How is it defined in your outlines?

This is your problem solution section - and where almost all the points are.

**Conclusion?** Add comments for best effect.

Here is more breaking down of the famed IRAC method.

"I" stands for "issue." This is the name of the legal principle in play on the hypo.

For instance if Rex slaps Regina, the issue is battery. If Rex inadvertently trips Regina, the issue is negligence. If Geezer kills Geezer in anger, the issues to be discussed are murder and manslaughter.

If Witness describes what she heard at an accident scene, the issues are hear-say (what she heard wasn't said in court) and some of the exceptions to it.

Here, the party calling W will use present sense impression, excited utterance, effect on the listener, the Hilmon use to prove action in conformity with words, and so forth.

If Citizen is asked not to pray at the mall, the issues are free speech, establishment of religion, and freedom of religion.

After you have decided what legal issues are raised, you state the rule for each rule either serially or as you use each issue.

Example of a rule:

“The 1st amendment to the US constitution, applicable to the states through its 14th amendment, does not allow interference with free speech by government except for reasonable time, place and manner restrictions that leave adequate alternative channels for the speech, or otherwise where the government proves a compelling interest in imposing the restriction, proves that the means employed (the law or regulation used) is necessary to achieve that interest, and is narrowly tailored to achieve its goals, which is called Strict Scrutiny.

“Cases decided on strict scrutiny will usually - though not absolutely always - go against the government, which has the burden of proving the elements of compelling state interest, necessary means, and narrow tailoring. [This paragraph is a comment.]

Next comes the arguments section. This is the section that carries most of the points for any essay.
